The P&C employs a canteen manager to operate the canteen service. A big thank you to Katie for all of her efforts and work over this financial year. The canteen manager is supported by a wonderful group of volunteers, without whom the canteen would not function.

Accounts

Access to the account has been Canteen Manager, P&C Treasurer and Sub committee convener. All accounts have been paid on time and invoices saved to Xero.

Initiatives and Activities.

Canteen Menu Price Assessment

Owing to the increasing cost of supplies during 2023, prices were continuously reviewed and adjusted as required.

Canteen Reusables

Reusable cutlery and containers were continued for use. There was a very high loss of cutlery, over 1000 during the calendar year. The use of this will be assessed during 2024 to determine if it continues. Reusable containers and cups were much more successful.

Volunteer Management

To demonstrate due diligence with food safety protocols, we have developed an annual induction tool which allows volunteers to sign in once a term to the Canteen safety procedures.

Preschool

Wednesday preschool orders were continued. There is good take up and can be supported within existing resourcing.

Meal Deals & Special Menu Days

Meal deals and special menu days provide an important revenue boost for the canteen. It's also a good way of encouraging people who don't usually purchase from the canteen to do so. To allow for easy order management all families are encouraged to order through the Spriggy Schools app. Cash orders are accepted at the discretion of the canteen manager

Recess Ordering

Online recess ordering continued and had a steady take up.

Grade 6 helpers

The year 6 Hospitality Team continued to support canteen counter service in 2022/23 and this program will continue in 23/24. There were fewer behaviour issues than in previous years. We will continue to use the Canteen agreement process.

Grant for Supporting Parental Engagement

During 22/23 the grant was acquitted. The final amount was used to provide a composting option for canteen food waste and terracycle boxes for school use.

Risks and Issues

Aspect	Risk
Cleaning	<p>HIGH</p> <ul style="list-style-type: none"> - The canteen manager does not have the capacity to clean during opening hours. - The space is shared with OSHC and do not have cleaning in their Deed with the school and have high staff turnover.
Record Keeping	<p>MEDIUM</p> <ul style="list-style-type: none"> - Cleaning record keeping is not undertaken. This will become a high risk from Dec 23 when it is required. - Not all volunteers are signing in or doing the induction.
Volunteers	<p>MEDIUM - We rely very heavily on a small group of volunteers, however have managed to increase the pool of volunteers over the FY.</p>
